#### **CALL TO ORDER**

Frank Koehler was selected acting Chairman and the meeting was called to order at 9:09 A.M.

#### **MINUTES**

Acting Chairman Koehler and Village Administrator for the Village of Bourbonnais apologized for not having a presentation prepared and stated that he would prepare one for the next meeting.

Mayor Carnahan from the Village of Herscher gave a presentation about the Village's recently adopted update to the land use and economic development portions of their Comprehensive Plan. He discussed the process in which the Plan was adopted and gave an overview of new developments coming to the Village.

Acting Chairman Koehler suggested that staff should investigate the possibility of holding social visits in a different municipality each month. Mr. Van Mill stated that he would have staff look into it.

A motion was made by Acting Chairman Koehler to recommend to the Regional Planning Commission that both plans be adopted as part of a Joint Land Resource Management Plan.
