1. Implementation of the 2005 Kankakee County Comprehensive Plan.
 - a. Seek adoption of supportive municipal resolutions for County Land Use Plan (Adopted: Chebanse, Irwin, Manteno, Momence, Sun River Terrace).
 - b. Promote the adoption of Joint Land Resource Management Plans. Work with municipalities and townships to update their plans to ensure consistency with the County Land Use Plan (Adopted: Bourbonnais, Herscher, Manteno).
 - c. Update Kankakee County Future Land Use Map.
 - d. Complete the update of subdivision regulations to include conservation development.
 - e. Initiate a report to determine if the minimum lot area for farm dwellings is adequate as regulated in the Kankakee County Zoning Ordinance.
2. County Subdivision Regulation Rewrite/Update.
 - a. Complete update and recommend revisions to County Board.
3. Update Land Evaluation and Site Assessment (LESA).
