**CALL TO ORDER**

Chairman Piekarczyk called the meeting to order at 3:00 P.M.

**PUBLIC COMMENT**

There was no public comment.

**MINUTES**

Mr. McBurney moved approval of the August 31, 2011 minutes. Mr. Piggush seconded the motion. Unanimous vote.

**AGENDA**

Mr. Piggush moved approval of the Agenda. Mr. McBurney seconded the motion. Unanimous vote.

**FY 2012 TIP AMENDMENTS**

Mr. Paukovitz stated that IDOT desires to move a programmed FY 2015 milling and resurfacing project on Court Street from Fifth Avenue to Lowe Road into FY 2012. He further stated that an existing project to mill and resurface Court Street from Eastridge to Nelson has been delayed by utility work, but would be completed.

Mr. Paukovitz stated that an additional \$350,000 project to upgrade traffic signals in the District with LED lights and battery backups has been placed in the IDOT program, and that local Mayors would receive their list of intersections to be retrofit in the near future. Mayor Adams stated that he had received his letter.

Mr. Tyson moved that the Technical Advisory Committee recommend adoption of the amendment for the Court Street project to the Policy Committee, and Mr. McBurney seconded the motion. Unanimous vote.

### **TRAFFIC SAFETY AUDIT**

Mr. Lammey stated that Mr. Fred Ranck has been retained for the Traffic Safety Audit project, and that Mr. Ranck would be making a presentation on the subject during the Policy Committee meeting. Chairman Piekarczyk asked Mr. Ranck to introduce himself. Mr. Ranck stated that he had worked for 12 years in Traffic Engineering for DuPage County, for 12 years as the City Traffic Engineer for the City of Naperville, and for the past 10 years as a Safety Engineer for the Federal Highway Administration.

### **ILLIANA STUDY**

Chairman Piekarczyk stated that Kankakee County personnel have been attending the Illiana Study meetings, including the most recent meeting on October 25, 2011. He displayed a Study Area map and a map with the 70 routes suggested by Study participants. He further displayed a map that summarized the 70 routes, and a map that contained the suggested routing from Kankakee County. Mr. Lammey stated that a Public Meeting on the subject would be held in Matteson on December 14, and stated that materials would be distributed on that subject.

### **WEBSITE**

Mr. Lammey displayed the advertisement for the MPO website, and navigated the website to show where documents in public comment and the most recent TIP would be posted.

### **OBLIGATED PROJECTS LISTING**

Mr. Lammey discussed the Obligated Projects Listing, a report required by federal law. He stated that the report had been filed before the deadline, and that he had contacted Federal Highway Administration personnel to discuss the filed report.

### **6000 N. ROAD**

Mr. McBurney stated that design work continues to progress, leading to a fall submittal.

### **BROOKMONT BOULEVARD**

Mr. McBurney stated that the project has been submitted as a TIGER application.

### **BURNS ROAD**

Mr. McBurney stated that an agreement has been submitted to IDOT for approval.

### **NEXT SCHEDULED MEETING**

Chairman Piekarczyk stated that the next meeting of the Technical Advisory Committee would be on January 25, 2012 at 3:00 P.M.

### **ADJOURNMENT**

Mr. Paukovitz moved adjournment, and Dr. Gingerich seconded. Chairman Piekarczyk adjourned the meeting at 3:21 P.M.
