#### CALL TO ORDER

Chairman Miller called the meeting to order at 10:30 AM, and welcomed everyone to the meeting.

## **PUBLIC COMMENT**

#### TRAFFIC SAFETY AUDIT

Mr. Lammey introduced Mr. Fred Ranck, the Traffic Safety Consultant for the project. Mr. Ranck explained the status of the project and explained the means used to identify locations to focus on for application of low-cost improvements to reduce traffic injury crashes. This was done by applying principles used in the Highway Safety Manual to predict the average number of crashes an intersection design should expect to have and comparing that to actual injury crash statistics. There are 81 intersections identified as having more than expected crash rates.

Mr. Ranck then reviewed each of the crash locations and prepared a worksheet of proposals for low-cost improvements for each. The recommendations include advance warning signs, double-up warning signs, larger signs, informational signs, improved timing on traffic signals, removal of sight obstructions and pavement marking improvements. Meetings are being held with engineers for the municipalities and IDOT to show them the progress so far. A comprehensive safety grant application for funds on a 90% / 10% basis will be submitted next year in December to include all jurisdictions. Each jurisdiction will be responsible for their own 10% matching share.

Mr. Lammey displayed Illiana maps showing some suggested routes, some of which go through

municipalities (like Essex). There will be a public meeting on December  $14^{th}$  from 5:00 pm to 8:00 pm, at the Matteson Hotel, Rt.30 @ I-57.
