

### RESOLUTION 2009-4

#### APPROVAL OF THE DRAFT FY 2010 UNIFIED WORK PROGRAM

- WHEREAS** the Federal Highway Act of 1962, as amended, and the Urban Mass Transportation Act of 1964, as amended, provides for an urban transportation planning process; and
- WHEREAS** the Kankakee Area Transportation Study (KATS) is the Metropolitan Planning Organization (MPO) for the Kankakee Urbanized Area, and the Policy Committee has the specific responsibility to direct and administer the continuing urban transportation planning process; and
- WHEREAS** the contract between the Illinois Department of Transportation (IDOT) and Kankakee County calls for a draft FY 2010 Unified Work Program (UWP) to be approved by the Policy Committee of the Kankakee Area Transportation Study prior to their March meeting; and
- WHEREAS** the draft FY 2010 Unified Work Program (UWP) for the Kankakee Area Transportation Study for FY 2010 was developed in accordance with the State and Federal laws and established local procedures and adopted by the Kankakee Area Transportation Study Policy Committee on February 24, 2009; **NOW, THEREFORE BE IT**
- RESOLVED** that the Kankakee Area Transportation Study Policy Committee adopts the draft FY 2010 Unified Work Program; **AND BE IT FURTHER**
- RESOLVED** that the Kankakee Area Transportation Study staff is instructed to transmit this amendment to the appropriate State and Federal agencies.


