#### APPROVAL OF THE FINAL FY 2016 UNIFIED WORK PROGRAM

- WHEREAS** the Federal Highway Act of 1962, as amended, and the Urban Mass Transportation Act of 1964, as amended, provides for an urban transportation planning process; and
- WHEREAS** the Kankakee Area Transportation Study (KATS) is the Metropolitan Planning Organization (MPO) for the Kankakee Urbanized Area, and the Policy Committee has the specific responsibility to direct and administer the continuing urban transportation planning process; and
- WHEREAS** the contract between the Illinois Department of Transportation (IDOT) and Kankakee County calls for a final FY 2016 Unified Work Program (UWP) to be approved by the Policy Committee of the Kankakee Area Transportation Study at their May meeting; and
- WHEREAS** the final FY 2016 Unified Work Program (UWP) for the Kankakee Area Transportation Study was developed in accordance with the State and Federal laws and established local procedures and recommended for adoption by the Kankakee Area Transportation Study Technical Advisory Committee on May 6, 2015; **NOW, THEREFORE BE IT**
- RESOLVED** that the Kankakee Area Transportation Study Policy Committee adopts the final FY 2016 Unified Work Program; **AND BE IT FURTHER**
- RESOLVED** that the Kankakee Area Transportation Study staff is instructed to transmit this amendment to the appropriate State and Federal agencies.
