### RESOLUTION 2012-9

#### APPROVAL OF THE FINAL FY 2013 TRANSPORTATION IMPROVEMENT PROGRAM

- WHEREAS** the Federal Highway Act of 1962, as amended, and the Urban Mass Transportation Act of 1964, as amended, provides for an urban transportation planning process; and
- WHEREAS** the Kankakee Area Transportation Study (KATS) is the Metropolitan Planning Organization (MPO) for the Kankakee Urbanized Area, and the Policy Committee has the specific responsibility to direct and administer the continuing urban transportation planning process; and
- WHEREAS** the contract between the Illinois Department of Transportation (IDOT) and Kankakee County calls for a final **FY 2013 Transportation Improvement Program** (TIP) to be approved by the Policy Committee of the Kankakee Area Transportation Study at their June meeting; and
- WHEREAS** the final **FY 2013 Transportation Improvement Program** (TIP) for the Kankakee Area Transportation Study for FY 2013 was developed in accordance with the State and Federal laws and established local procedures and adopted by the Kankakee Area Transportation Study Policy Committee on June 27, 2012; **NOW, THEREFORE BE IT**
- RESOLVED** that the Kankakee Area Transportation Study Policy Committee adopts the final **FY 2013 Transportation Improvement Program**; **AND BE IT FURTHER**
- RESOLVED** that the Kankakee Area Transportation Study staff is instructed to transmit this approval to the appropriate State and Federal agencies.
