

**Ordinance of the County Board
of
Kankakee County, Illinois**

**RE: COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR
KANKAKEE COUNTY, ILLINOIS 2017-2018 FISCAL YEAR**

WHEREAS, the Kankakee County Board, at its November 29th, 2017, meeting, has reviewed, considered and determined the amounts of monies estimated and deemed necessary to meet and defray all the legal liabilities and necessary expenses to be incurred by November 30, 2018, and has further listed specific detailed statements of budgeted itemized county expenditures in the attached recommended budget, and has caused the recommended budget to be conveniently available to public inspection pursuant to 55 ILCS 5/6-1001; and,

NOW THEREFORE, BE IT ORDAINED by the Kankakee County Board, that the 2017-2018 fiscal year begins December 1, 2017 and ends November 30, 2018.

NOW THEREFORE, BE IT FURTHER ORDAINED by the Kankakee County Board that the attached recommended budget be and the same is hereby adopted and appropriated as the Combined Annual Budget and Appropriation Ordinance of Kankakee County for the fiscal year beginning December 1, 2017, and ending November 30, 2018.

NOW THEREFORE, BE IT FURTHER ORDAINED by the Kankakee County Board that the amounts listed as budget amounts for the fiscal year from December 1, 2017, through November 30, 2018, in the attached schedules of the Combined Annual Budget herein adopted by and the same are hereby appropriated for the purposes herein specified, or so much thereof as may be authorized by law. Supporting documents are made a part of this ordinance and incorporated herein by reference. (attached as Exhibit A)

NOW THEREFORE, BE IT FURTHER ORDAINED that the budget and appropriation herein made and ordained be known as the Combined Annual Budget and Appropriation Ordinance for Kankakee County, State of Illinois, for fiscal year 2017-2018.

ADOPTED, APPROVED and ORDAINED by the Kankakee County Board of Illinois at its meeting of November 29, 2017.
